

## MUNICIPAL's "Big Game MUNICIPAL Hat Sweepstakes" Official Sweepstakes Rules

### Some Basics:

No purchase is necessary to enter or win. A purchase or payment will not increase chance of winning. Void where prohibited or restricted by law.

The Sweepstakes runs from Feb 2, 2020 at 12:00:01 a.m. (PT) and ends on Feb 3, 2020 at 12:00:01 a.m. (PT) ("Sweepstakes Period").

By entering the Sweepstakes, each entrant ("Entrant") agrees to abide by these Official Sweepstakes Rules ("Official Rules") and with Sponsor's General Terms and Conditions.

To enter the Sweepstakes, you must fill out the survey attached to the official Sweepstakes page url <http://www.municipal.com>.

Limit of one entry per person during the entire Sweepstakes Period. Subsequent entries will be void and may void prior entries. All entries become property of Sponsor and will not be acknowledged or returned. Anyone found to use multiple Twitter or email accounts to enter will be ineligible.

### Who is Eligible:

The Sweepstakes is open to anyone who (i) is a legal resident of one of the 50 United States or D.C. and located within the United States at the time of entry; (ii) is at least 18 years of age as of the date of entry.

Employees of MUNICIPAL ("Sponsor"), and its parent company and their respective subsidiaries, affiliates, suppliers, advertising agencies, and the families and persons living in the same household as such individuals, are not eligible to participate. This Sweepstakes is void outside of the Sweepstakes Territory. This Sweepstakes is intended for viewing in the United States and

Canada only and shall be construed and evaluated according to United States and California law.

**How to Enter and Winner Selection:**

You must “subscribe” on the official sweepstakes website (<http://www.municipal.com>). Limit of one entry per Entrant for the Sweepstakes.

By submitting an entry Entrant is granting Sponsor all rights, titles and interest in the submitted entry. By submitting an entry Entrant is also granting Sponsor and its agencies all rights to use Entrant’s name and/or likeness for advertising and trade purposes without further compensation or authorization, worldwide and in perpetuity, in any and all forms of media, now known and hereafter devised, unless prohibited by law.

No illegible, incomplete, forged, or altered entries will be accepted. All entries become the exclusive property of the Sponsor and will not be returned or acknowledged.

**Selection and Notification of Winner & Description of Prize:**

Within 72 hour(s) of the Contest Deadline, 100 entries will be randomly selected by Sponsor from among all eligible entries received during the applicable Sweepstakes Week (as determined by Sponsor at its sole discretion). Prize will be awarded upon verification. Non-winning Entrants will not be notified.
